## eAIP Amendment Service 2022 Revised

DC-ANSP Dutch Caribbean Aeronautical Information Service unit's eAIP Amendment Service for 2022 will be modified. Please take note of the following information provided below.

The DC-ANSP Dutch Caribbean AIS unit is charged with the publication of the elements of the Dutch Caribbean Aeronautical Information Products, which contains aeronautical information for the following Dutch Caribbean territory islands: Aruba, Bonaire, Curaçao, Saba, Sint Eustatius and Sint Maarten.

The elements of the Dutch Caribbean Aeronautical Information Publications Products, including AIP Supplements (SUPs) and Aeronautical Information Circulars (AICs) are available on the DC-ANSP's website in the AIS webpage, and are transmitted as well via e-mail to registered clients.

Valid NOTAMs are included in the monthly NOTAM Summary, also transmitted via e-mails to registered clients.

## Client registration and yearly registry upkeep

The <u>DVD copy</u> of the Dutch Caribbean Aeronautical Information Publications Products are <u>per effective date 01 JAN 2022 no longer available</u>. The online versions of the eAIP will be available and remain free of charge. Hard copy remains not available, the eAIP and/or its related products may or can be printed by the user at own discretion.
